#### **Term and Conditions**

- 1. <u>Transport:</u> The Dam must come to the Sire unless specified. If agreed upon, the Sire's owner(s) will transport the stud to the designated place, area, address mentioned below: \_\_\_\_\_\_
- 2. Note, there is a transport fee of \$50-300 per trip. (Depending on mileage) This covers gas and mileage. Arrangements must be agreed upon before the transport and if changed can be subject to a fee.
- 3. <u>Breeding Environment:</u> Once the 2 parties arrive, proper introductions must be met. The breeding should be witnessed by both parties. A proper fenced-in area is a must, that way both canines could be bred naturally. If a forced breeding is required, both parties must agree before initiating. If this is the female's first breeding, her owner(s) must be present in the event that she becomes nervous and needs to be calmed down. Most unbred females tend to panic once tied, her owner(s) is responsible to keep her calm during the process to prevent damage to the sires reproductive organs.
- 4. <u>Mating Terms:</u> The Sire and Dam must be of proper age and in perfect health.( Vaccine and health test documentation copies are required to be provided to each other by both parties) The Sire's owner(s) guarantees 2 or more ties. If those 2 ties are not produced during one visit, another visit can be scheduled. Subject to a transport fee, see above. The Dam must be in her 11th-15th day of her heat cycle. The Dam's owner(s) are responsible to track the start of her bleeding cycle and notify the Sire's owner(s) immediately. This is to insure accuracy and a higher probability of conception.
- 5. <u>Failure to Conceive:</u> In the event that the Dam cannot conceive from a proven stud during their 1st breeding, her owner(s) have a right to schedule another breeding at her next cycle at no extra cost. This failed conception will need to be proven with an official vet ultrasound or x ray record. Paperwork will need to be provided to the studs owner(s) within 25 days of the date of the breeding. (Miscarriage by the dam is not the studs fault and isnt entilted to a rebreeding.) If, during the complimentary re-breeding, the Dam isn't able to conceive (proven again by the vet within 25 days of the breeding), the contract is terminated and the fee is not refundable.
- 6. <u>Definition of a Litter:</u> At least (2)or more puppies born alive. If any less are born, the Dams owner(s) have a right to a complimentary re-breeding at no extra cost. Must provide proof.
- 7. <u>Pick of Litter Terms:</u> If both parties decide on the "Pick of the Litter" payment option, the Sire's owner(s) have the legal right to choose a puppy first before any are sold. If in an event that the puppy gets injured or dies before 8 weeks, the Stud's owner(s) have a right to choose another puppy if available, or receive a payment fee according to the 1st payment option noted above. Included with the puppy are the vet records, vaccine records, registration paperwork with full rights, and deworming records. The dam's owner cannot sell their litter before the stud owners pick. Withholding female puppies for evaluation by the dam's owners isn't permitted until after the stud's owners have chosen.
- 8. <u>Caring / Whelping of the Litter</u>: It is the responsibility of the Dam's owner(s) to provide sufficient prenatal and post whelping care for the Dam and puppies born. The Studs owner(s) can provide support / advice throughout the breeding process.
- 9. <u>Registration Paperwork:</u> Copies or original registration paperwork must be provided to both parties at the signing of the contract. If the Dam cannot conceive, her owners cannot use the Studs information in the future and must return the registration copies to the Stud's owner(s). Using the stud's or dam's registration number for future litters is forgery and isn't permitted as well. Legal actions will be taken if breached.

We have read, reviewed, understood and agreed the above conditions of stud service and agree to all the terms of this stud service agreement/contract. This contract is entered between the mentioned parties above. Any violation from either party can result in termination or be given the right to pursue legal actions. This a legally binding contract once signed and dated by both parties.
